

STUDENT DIGITAL CITIZENSHIP AGREEMENT SECONDARY SCHOOL – 2024 / 2025

This agreement will help everyone in our school community to use digital technology safely and supportively, to enhance learning at Tenby. Please read the content carefully and sign to accept the agreement.

Privacy & Security - We care about everyone's privacy.

Students learn how to protect personal information and gain a deeper understanding of their data privacy rights so they can advocate for themselves and others.

- I will only access the INTERNET via the school's student INTERNET connection. I will not use any other means to connect to the systems needed in school.
- I will protect my own and others' information online.
- I will not share personal information about myself or other students online e.g. home address, phone number, full name, personal photos etc.
- I will keep my passwords private and will not share usernames with others, except parents.
- I will always log off before leaving a device or computer unattended.
- I will not log in with another student's username and password.
- I will only record or photograph people and post images with their permission.

Relationships & Communication - We know the power of words and actions

Students reflect on how to build positive relationships, avoid risky online talk, and understand why some topics and conversations can best lend themselves to certain mediums.

- I communicate responsibly and kindly with others.
- I will be polite and respectful in my online communications with others.
- I will not change the work of others when collaborating in shared spaces e.g. during collaborative work or via shared collaborative platforms like Teams.
- I will inform my parents and teachers, if someone cyber-bullies me or sends me inappropriate pictures or messages.
- I will be aware of whom I am sharing my files with (keeping them private, sharing with teachers and classmates or posting them publicly).

- I will report any attacks or inappropriate behaviour directed at others or myself to my tutor, Head of Year, or other adult at school.
- I will refuse to be a "bystander", instead I will be a role model to others and support victims of cyber bullying.

News & Media Literacy - We are critical thinkers and creators.

Students identify credible and trustworthy information sources and reflect on their responsibilities as thoughtful media creators and consumers.

- I give proper credit when I use others' work.
- I identify credible and trustworthy information sources.
- Plagiarism is taking the ideas of writings of others and presenting them as if they were original ideas. I will not plagiarise work I find on the Internet.
- I will respect copyright laws by citing my sources as required (for example in coursework essays.)

Media Balance & Wellbeing - We find balance in our digital lives!


Students go beyond screen time to explore the impact their digital lives can have on their well-being and relationships while learning to balance media in their everyday lives.
